Each year, more than 3 million food service employees and 1 million guests are injured as a result of slip-and-fall accidents

This incident, stemming from neglectful floor maintenance, robbed her of livelihood and well-being. Evidence revealed the restaurant's prolonged negligence, further substantiated by Department of Health citations.
