NEW YEAR NEW LAW

Louisiana's New Hands-Free Driving Law: What You Need to Know

As of January 1, 2026, Louisiana has fully begun enforcing a new hands-free driving law that makes it illegal to drive while holding a cellphone or other handheld electronic device.

Under the law drivers may only use phones through hands-free technology such as Bluetooth, voice commands, Apple CarPlay, Android Auto, or a securely mounted GPS system. Any physical interaction with a phone while the vehicle is in motion is prohibited.

Exceptions are limited to emergency use (reporting a crash, hazard, or other urgent situation) and when the vehicle is lawfully parked. Simply stopping at a traffic light or in traffic does not make handheld use legal.

Law enforcement began issuing warnings during a grace period that ended December 31, 2025, and citations are now being issued under the fully effective law.

The hands-free law aims to reduce distracted driving, a significant factor in traffic crashes and fatalities. Fewer distractions mean safer roads for motorists, pedestrians, and roadside workers alike.



Celebrating 25 Years of Service




Our firm began 2025 by giving back to ChristFit Gym, a local nonprofit ministry who serves the community through a blend of faith and fitness.
