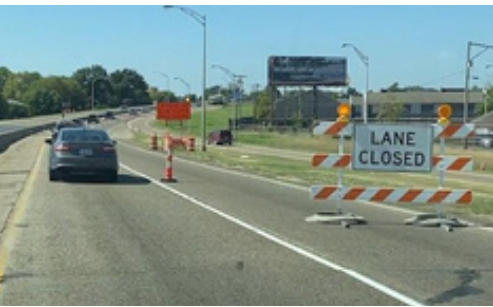

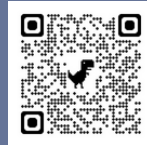

# SEMI TRUCK ACCIDENT

Our client was air lifted 15 miles from the scene of the accident to LSUHSC due to the severity of his injuries. According to his medical team, "The patient suffered a severe trauma that left in him multiple morphological and functional changes that interfere with his normal daily life, confirmed by the objective measurements and features found on MRI sequences."
