● GET REPAIR QUOTES

Obtain two or three quotes for all repairs needed.

● KEEP COMMUNICATION RECORDS:

Save proof of all communications with insurance and repair companies, including screenshots, voicemails, and emails.

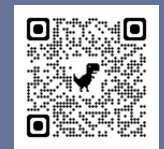
